C.Edward Acker, who built up Air Florida, left them in Sept. 1981, for Pan American, going broke.

Pan America, CIA, Anti-Castro Cubans, Air America, described in <u>Air America</u>, Christopher Robbins, Putnam's, N.Y, 1979.

Wash.Post, Jerry Knight, 1/15/82. Wealth, competition of Air Florida. "London, Costa Rica, Honduras, Venezuela, Jamaica, dozens of US."

"CAB DRIVER WITNESS SOUGHT, PROBE OF AIR FLORIDA CRASH,"S.F.EX,1/18/82
Air pilot, "mystery witness", "landing gear down, called command center.

"History of showing up at disasters, from Danbury Fed. Prison, Marriott Hotel with victim families. "Wanted in Trenton, N.J."

SPOOKS, JIM HOUGAN, Bantam, 1978, N.Y. Page 458, 459

"Spanish-born priest, Jose Gardeano, Jose Aramiya, functioned as courier for underground banks, bribe money, CIA, sums hand carried aboard planes. Lockheed, Kissinger, Japanese Tanaka, Richard Allen pals. Were families of plane crash "comforted" by Mafia, Fed. agent?

4:07,D.C.Fire Dept sent, 20 minutes before ambulance at bridge. City "icebreaker boat",15 min.to arrive, 45 min.to suit up.
