ON THE DIRECTION OF THE FATAL SHOT

"Twenty feet below the bathroom window..there is a vacant lot .. covered with bushes 12 to 15 feet high.Dr.King's chauffeur, Solomon Jones, told reporters a few minutes after the shooting that "just after the shot fired, a man with a sheet over his head ran out of the bushes heading south".

"Cornbread "Carter, another witness, said he saw "the man" fire the shot from the bushes and then "take off".

"From a concealed position in a firehouse..police were watching the area of Dr.King's room. Both firemen and policement..heard the shot, and they all thought it came from the bushes, not from any sindow 20 feet above."

### RANDOLPH IRVIN ROSEN, GEN.CLYDE J.WATTS, MAJ.GEN.EDWIN A.WALKER

James Earl Ray testimony:

"Coming from Mexico to USA, via Tiajana, a card belonging to Mr. Randolph Irvin Rosen was in my car".

"Upon request, THE LATE Clyde Watts, Oklahama, investigated in 1964 and reported there after that Randolph Irvin Rosen was in fact Randolph Irvin Rosenson".

Congressman Stokes, "About the car, Rosen, what would that tell us about Raoul?"

James Earl Ray "I found out about his correct name, Rosenson, from an attorney in Memphis, Merchant J.Ryan, and he went down and got the transcript from the fifth circuit archives and I threw it away because the only thing I wanted to know was the fact that Rosenson was a pauper but he had three or four expensive attornies from New Orleans. And later Mr.Ryan told me Mr.Rosenson was an FBI informer..so I THINK THINGS LIKE THAT SHOULD HAVE BEEN LOOKED INTO and I don't know if they ever were or not."

#### CHARLES STEPHENS

Drunk "witness" to man leaving rooming house where Ray's rifle was left under the bed. Star wit ness if Ray had a trial.

GRACE WALDEN STEPHENS, Common-law wife

"Saw a man much shorter than Ray, weighing no more than 1251bs. Grace locked in "mental" institution for ten years.
