## EVIDENCE MISSING, JFK ASSASSINATION

Oswald's CIA "201 file, 39 pages".

If 39 pages are missing, what do the other pages have?
Robert Blakey and the House Select Committee concluded that their information on JFK would be incomplete "until the USSR turns over the KGB files". What about the CIA, DIA, NSA, Navy Intelligence files?

Brains of John Kennedy, with multiple bullet fragments in them. Blame put upon deceased Robert Kennedy. Who had them in the Archives?

Bullets from JFK tested by J.E.Hoover in 1964 Where were these bullet fragments taken? Who had them?

Bullets tested by FBI from John Connally's wrist in 1964. Why aren't they in Archives in 1978?

JFK bullets tested 1964: Four samples, all different weights. JFK bullets tested 1978: One 41.6 Fill, another 5.4 Mill. Different than 1964 bullets.

Connally bullets, 1964: two weighed 2.3 mill. Third weighed 1.62mill. Connally bullets, 1978: one weighed 16.4mill, 2nd weighed 1.3mill.

EVIDENCE NOT USED BY HOUSE SELECT COMMITTEE

Picture of man in Dal-Tex Building , behind JFK.

House Select Committee didnt examine these closely.

Robert Grodon showed them the first day.

Tom Canning testified shots could come from there.

Members of Crime-Syndicate were there, Suspects were taken here.

JOHN CONNALLY CLOTHING

House Select Committee didnt attempt to find out why entry, exit fibres were washed from these garments immediately, before the Warren Commission got to them.

This was Item #3 on my position paper in 1976, after Evidence Destroyed. How did Connally's clothing get to the cleaners? Somebody had to pick them up from Cong. H. Gonzalez. Somebody had to order them destroyed.

CAR INTERIOR OF JEK, Never examined before torn out, 48 hours later.
AUTOSPY X-RAYS, not used for autopsy on JEK. Not developed.

STREET SIGN, Dealey Plaza, removed day of assassination. WHERE? WHO? Street Light, Dealey Plaza, removed day of assassination. WHY? WHERE? WHO? Lee Harvey Oswald Post Office application, Dallas, Texas, destroyed. Federal regulation, preserve two years. This was ignored.

Oswalds Passpott Application, Vol. XXIII, page 188. "THIS DOCUMENT WAS ACCOMPANIED BY PAGE FROM CIA. Nov. 23, 1963, IT WAS BURNED".

Original Autopsy notes burned, Autopsy different from FBI report. Commander Hunes, "it had too much blood on it".

Notes in Dallas jail, last words of Lee Harvey Oswald, destroyed.

Office files of Dean Andrews, Oswald's New Orleans attorney, destroyed.
