MEMORANDUM FROM LEON D.HUBERT, JR, BURT W.GRIFFIN, WARREN COMMISSION LEGAL STAFF, TO MR.JOSEPH BALL AND DAVID COCKEYED SIMP BELIN. March 10,1962

Subject" The testimony of Mary Bledsoe and William W. Whaley."

"William Whaley has stated he was acquainted with Jack Ruby prior to Ruby's killing Oswald. Although we do not suggest that Whaley may be linked to Ruby in any kind of conspiratorial plot, his knowledge of Ruby suggests that, if Ruby were involved in any sort of plot wherein OSWALD WERE TO BE A DUPE, a conspiratorial group might have used LARRY CRAFARD, who many persons state closely resembles Oswald, as a deliberate decoy, or that Crafard himself might be the real assassin, and that fortuitiously, both Crafard and Oswald happened to take taxicabs. In that regard, it might be considered that an assassin or conspirator in a plot to assassinate the President was not detained for any period in the Schoolbook Depository, as was Oswald, might very well have entered a cab at 12:30 PM, making the trip that Whaley claims Oswald took."

Oswald . claimed he got into the "white station wagon" of Michael Paine, employee of G. William Miller, now Secy. of Treasury. Gehlen-Dornberger. Miller nest at Bell Helicopter.

The attornies realized an imposter could be in Whaley's cab.
