Helter Skelter, Charles Manson, "Mass murderer", Charles Watson, "Involved in Tate and La Bianca murders." MANSON NEVER IN TATE HOME, NEVER KILLED ANY OF THEM. Ball, CIA atty. Warren Commission. Erhlichman, DeLorean.

"Joseph Ball, Interviewed Manson, competent to represent himself."

Knew Pancoast since 1978, 5 yrs.ago.Called STEINBERG TO GO TO JAIL, see him." Jail visit, dimes with Pancoast, brought female, tapes.
