PILOT ERROR BLAMED IN CRASH THAT KILLED CANDIDATE FOR SENATE

"The airplane crash that killed Va.Republican senatorial candidate Richard D.Obenshain was caused by pilot error and misjudgements. The pilot had too little experience.Investigators could not determine who was piloting.Killed were Obenshain, 42.Three others were named, identified, but not the pilot.No name. Sen.John Warner took over Obenshain's nomination and won by 8,000 votes because of "my record of wanting segregation as Secretary of the Navy".
